Publication Release Agreement

If I divulge my PIN number and password to any third party my participation in TWP Talent Bank will be immediately revoked. If I am under 18, I have obtained permission from my parent or guardian.

As consideration of TWP, for providing me information about and opportunities for personal exposure on the World Wide Web (WWW), I waive and release TWP, TWP owners, TWP employees, and TWP financial backers from any liability whatsoever arising from my participation in TWP offerings, products, or services. This waiver extends to any and all of my, heirs, assigns, and/or other interested parties of my cause. Pursuant to this waiver and release, I, by signing this document, confirm and agree to the following. That:
